2015 FEDERAL INCOME TAX FILING REQUIREMENTS

This information is from the 2015 IRS 1040 and 1040A Instruction Booklets (see www.irs.gov).

Amounts listed are for people under the age of 65; if you are over 65, please refer to the IRS instruction booklets.

For most people, a tax return must be filed with the Internal Revenue Service (IRS) if their 2015 income was at least:

Single dependent student (your parents or someone else can claim you as a dependent)	\$6,300 <i>(earned income)</i> (\$1,050 un-earned income)	Married, filing separately	\$4,000 <i>(gross income)</i>
Single, if claiming self	\$10,300 <i>(gross income)</i>	Head of household	\$13,250 <i>(gross income)</i>
Married, filing joint return	\$20,600 <i>(gross income)</i>	Qualifying widow(er) with dependent child	\$16,600 <i>(gross income)</i>

Earned income includes salaries, wages, tips, professional fees, and taxable scholarship and fellowship grants.

Unearned income includes taxable interest, ordinary dividends, and capital gain distributions. It also includes unemployment compensation, taxable social security benefits, pensions, annuities, and distributions of unearned income from a trust.

Self-employment: You have to file an income tax return if your net earnings from self-employment were \$400 or more.

Who is self-employed?

- You carry on a trade or business as a sole proprietor or an independent contractor.
- You are a member of a partnership that carries on a trade or business.
- You are otherwise in business for yourself (including a part-time business). A trade or business is generally an activity carried on for a livelihood or in good faith to make a profit (i.e. babysitting, lawn care, repairs, etc.)
