## Missing Students Who Reside in On-Campus Housing

If a member of the University community has reason to believe that a student who resides in oncampus housing is missing, he or she should immediately notify the UIndy Police Department at (317) 788-3333.

UIPD will generate a missing person report and initiate an investigation. After investigating the missing person report, should UIPD determine that the student is missing and has been missing for more than 24 hours, Uindy will notify the Indianapolis Metropolitan Police Department (IMPD) and the student's emergency contact no later than 24 hours after the student is determined to be missing. If the missing student is under the age of 18 and is not an emancipated individual, UIndy will notify the student's parent or legal guardian immediately after UIPD has determined that the student has been missing for more than 24 hours.

In addition to registering an emergency contact, students residing in on-campus housing have the option to identify confidentially an individual to be contacted by UIndy in the event the student is determined to be missing for more than 24 hours.

If a student has identified such an individual, UIndy will notify that individual no later than 24 hours after the student is determined to be missing. Students who wish to identify a confidential contact can do so through the UIndy Residential Life web site.
