Electives

Elective courses are chosen in consultation with an academic advisor. The elective component can be fulfilled by any college-level course offered at the University of Indianapolis or accepted in transfer from an accredited college or university. Students may use these elective hours to complete additional majors, minors, concentrations or certificate programs.

Notes

1. IBUS 201 also meets the Global Awareness requirement in the General Education Core.
2. BADM 332 also meets the Writing/Speaking across the Curriculum requirement in the General Education Core.
3. BADM 439 also meets the Capstone requirement in the General Education Core.
4. MATH 220 has prerequisites of MATH 105 Intermediate Algebra and MATH 150 Finite Mathematics or MATH 180 College Algebra and Trigonometry: MATH 150 OR MATH 180 satisfy the Mathematic requirement of the General Education core.
5. The Bachelor of Science in Business Administration requires a minimum of 120 credit hours.
6. Adult Accelerated Programs students must satisfy the General Education Core requirements with exceptions. SCAS 101 fulfills the FYS and NSE requirement. Lecture/Performance and Spring Term are not required.
7. A grade of C- (1.7 on a 4.0 scale) or higher is required in all courses applying toward the Business Administration Major, including the General Education Core courses.
8. Students must maintain a cumulative GPA of 2.0 or higher in all accelerated courses to remain in good standing in the accelerated program.
9. Students are responsible for knowing and fulfilling the requirements for course prerequisites for graduation. These requirements are listed in the Academic Catalog.
